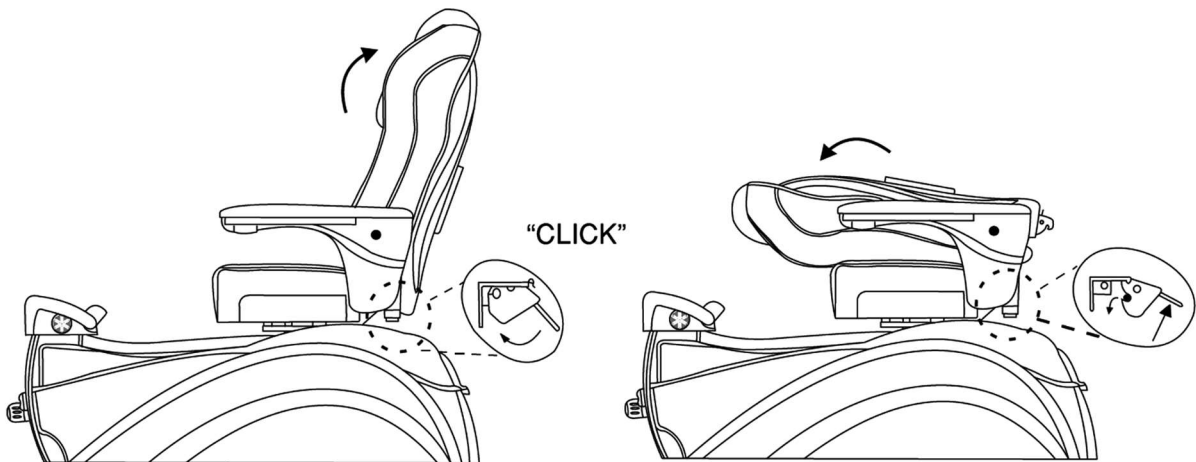
WALL CLEARANCE & SPA to SPA RECOMMENDED CLEARANCE



VERY IMPORTANT: Both the back of the chair and seat are adjustable. When the seat is at a maximum incline, one must allow 18"(44cm) from the back wall to the foot spa. This minimum distance assures an unobstructed recline. Failure to follow this required dimension might damage your spa components and plumbing connections, which will void your warranty.

INSTALLATION OF PEDICURE SPA SEAT

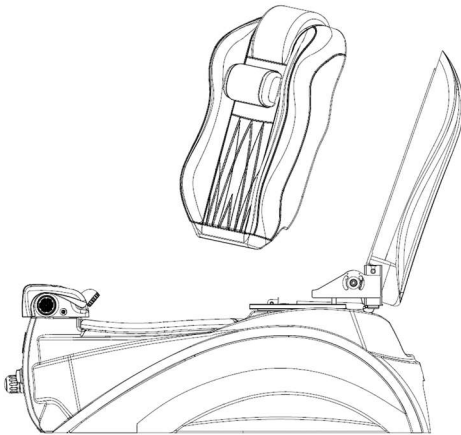
1. FOLD & UNFOLD BACK-REST MASSAGE



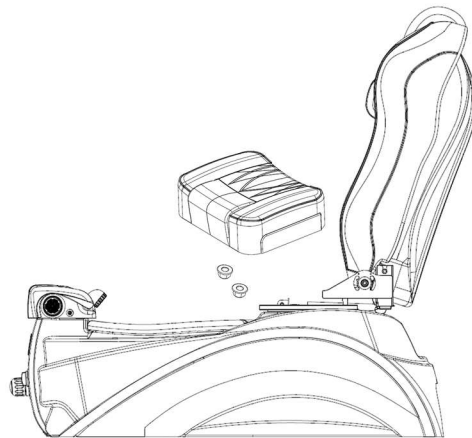
Raise the backrest until a "click" is heard. Make sure the lever is locked before operating

To fold down the backrest: Lift up lever handle and push the backrest downward

2. ASSEMBLE THE BACK AND SEAT CUSHION

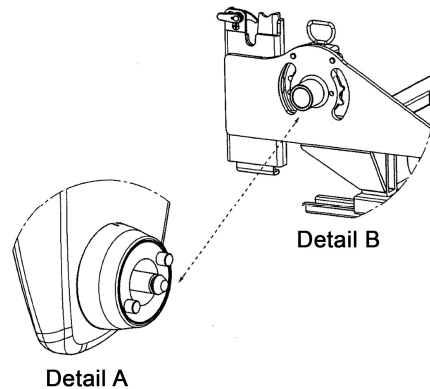
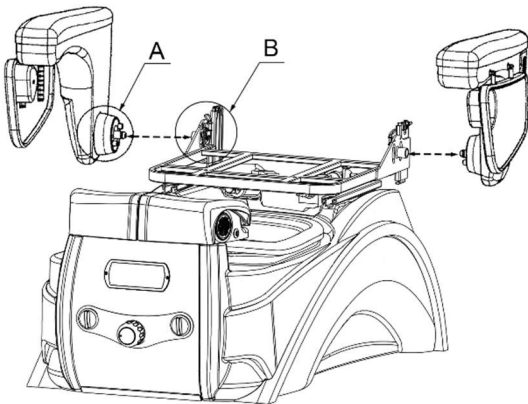


Align the back cushion to fit on the back shell. Push the cushion firmly onto the VELCRO straps.

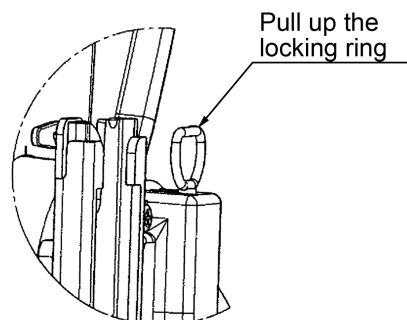
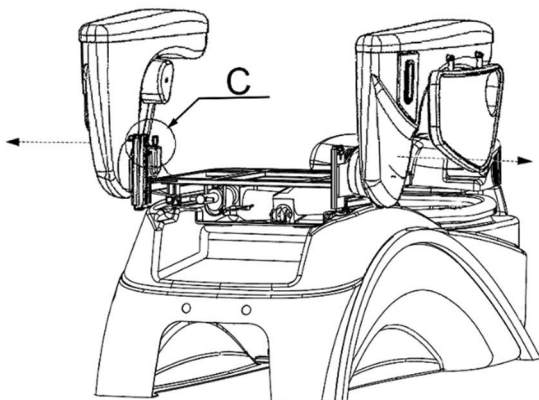


Align the screws to the holes on the seat frame. Put the seat cushion onto the frame. Then use the provided screws to secure the seat.

3. ASSEMBLE THE ARM-RESTS



- 1) To install the armrest, position the armrest horizontally as shown above. Align the rods and the notches as shown in Detail A and B. Fully snap-in the armrest until hearing a “click” sound.

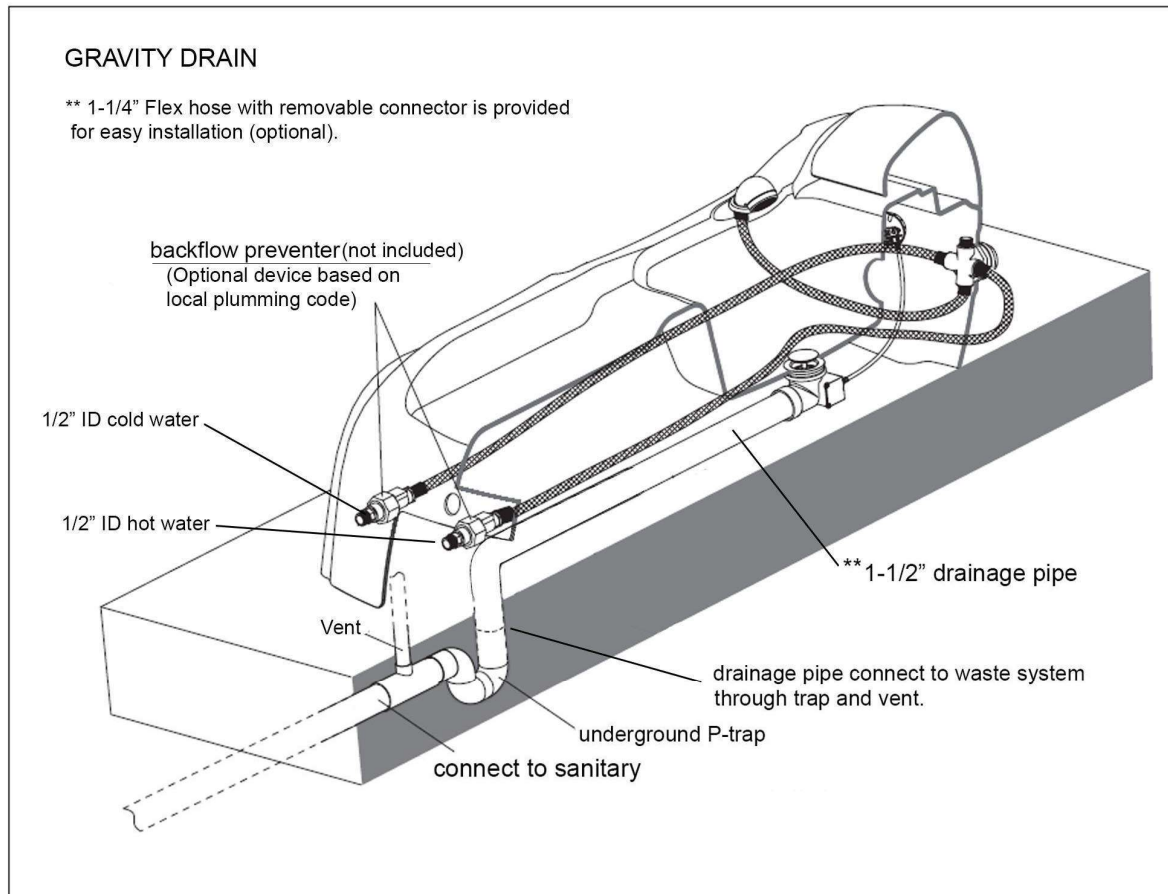


- 2) To remove the armrest, pull up the locking ring as shown in figure and Detail C, then pull out the armrest.

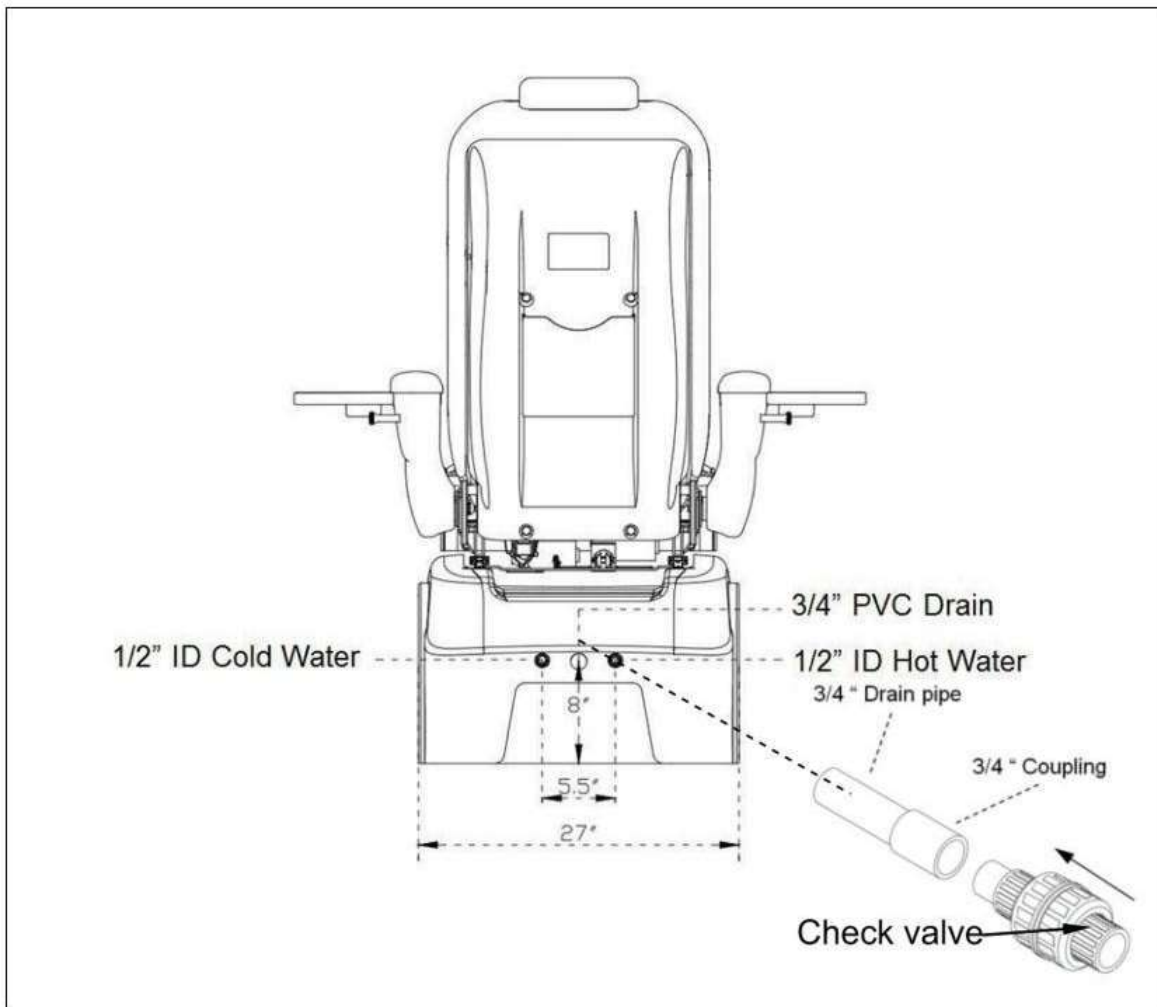
INSTALLATION OF PLUMBING SYSTEM

NOTE: The drainage and water supply system installation require a licensed plumber. Instructions and local plumbing codes need to be carefully compiled to pass the city inspections.

1. GRAVITY DRAIN

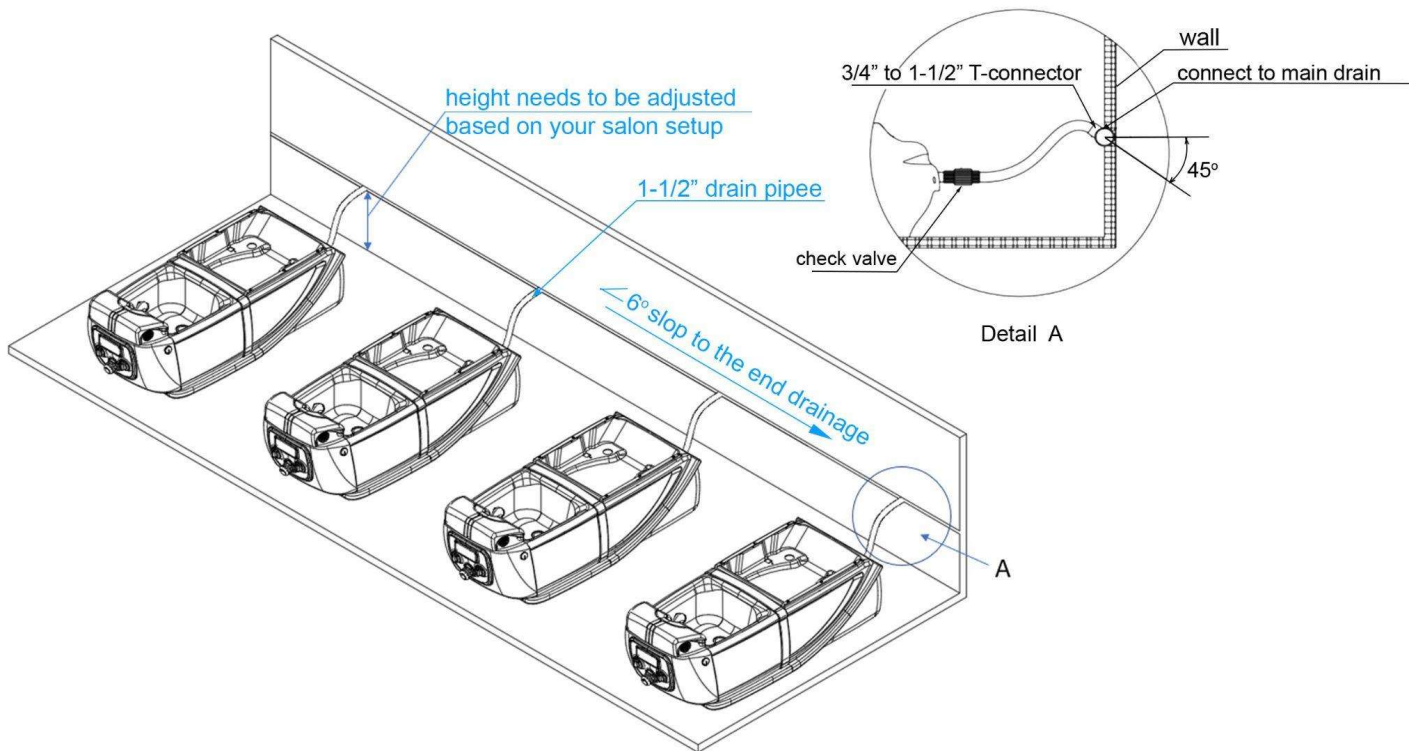


- 1) The gravity drainage installation should comply with SECTION 701.0, 2018 UPC.
- 2) Trap, vent, and connectors should comply with SECTION 1001.1 and 1001.2 UPC.
- 3) An alternative code needs to be complied with by the states not adopting UPC.
 - a) Drainage system: SECTION 701.2 and 702.2 IPC (or local plumbing code)
 - b) Trap, vent, and connectors: SECTION 1002.1 and 1002.2 IPC (or local plumbing code)
- 4) The installer/plumber is responsible for obtaining and complying with the local plumbing code for inspection. If any assistance is required from the vendor's side, please contact our customer service.

2. POWER DRAIN

- 1) The power drainage installation should comply with SECTION 807.1, 2018 UPC.
- 2) Trap, vent, and connectors should comply with SECTION 1001.1 and 1001.2 UPC.
- 3) An alternative code needs to be complied with by the states not adopting UPC.
 - a) Drainage system: SECTION 701.2 and 702.2 IPC (or local plumbing code)
 - b) Trap, vent, and connectors: SECTION 1002.1 and 1002.2 IPC (or local plumbing code)
- 4) The installer/plumber is responsible for obtaining and complying with the local plumbing code for inspection. If any assistance is required from the vendor's side, please contact our customer service.

4. HOT/CODE WATER SUPPLY SYSTEM

NOTE: The drainage and water supply system installation require a licensed plumber. Detailed instructions can be found in the manual book. Instructions and local plumbing codes need to be carefully compiled to pass the city inspections.

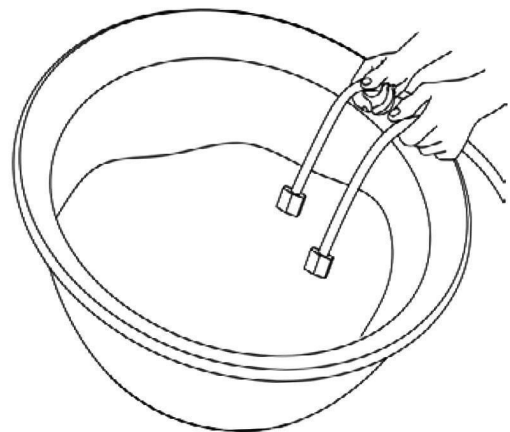


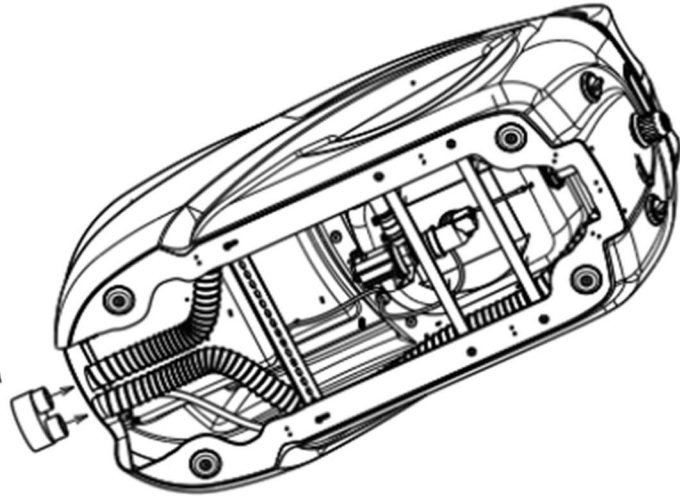
Figure 1. Drain water to remove debris before installing new spa chair.

New constructions: drain a good amount of water in a bucket to remove all debris from the new hot/cold water pipes before connecting to new SPA chairs (figure 1).

Replacement Spas: Make sure to use new hot/cold water hoses to replace old ones before installing a new Spa chair. The old debris, rubber, or plastic chips could clog the water inlet system.

** Failure to do so will invalidate the warranty.

(The Spa comes with a preinstalled ventilation system to fulfill the regulations for some states. Please contact your state department for the requirements and regulations)



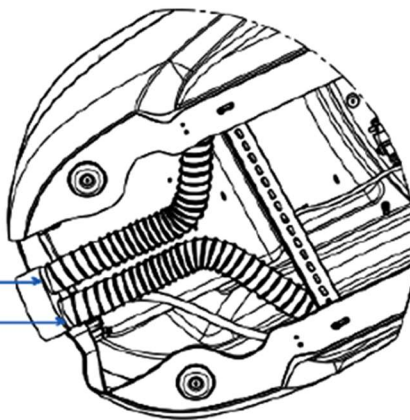
Note: Make sure the mounting hole is positioned upward before installing to the Air-vent hoses



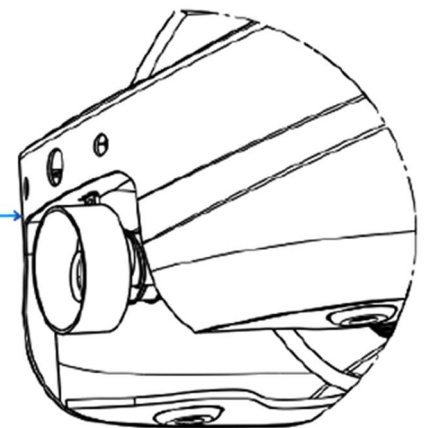
Step 1: Connect the two Air-vent hoses to the connector

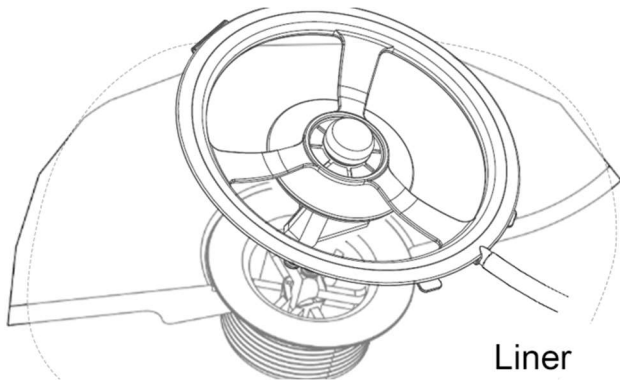


Plug in the other end of the pipe to the Air-connector

2. SETUP THE Eco-Jet



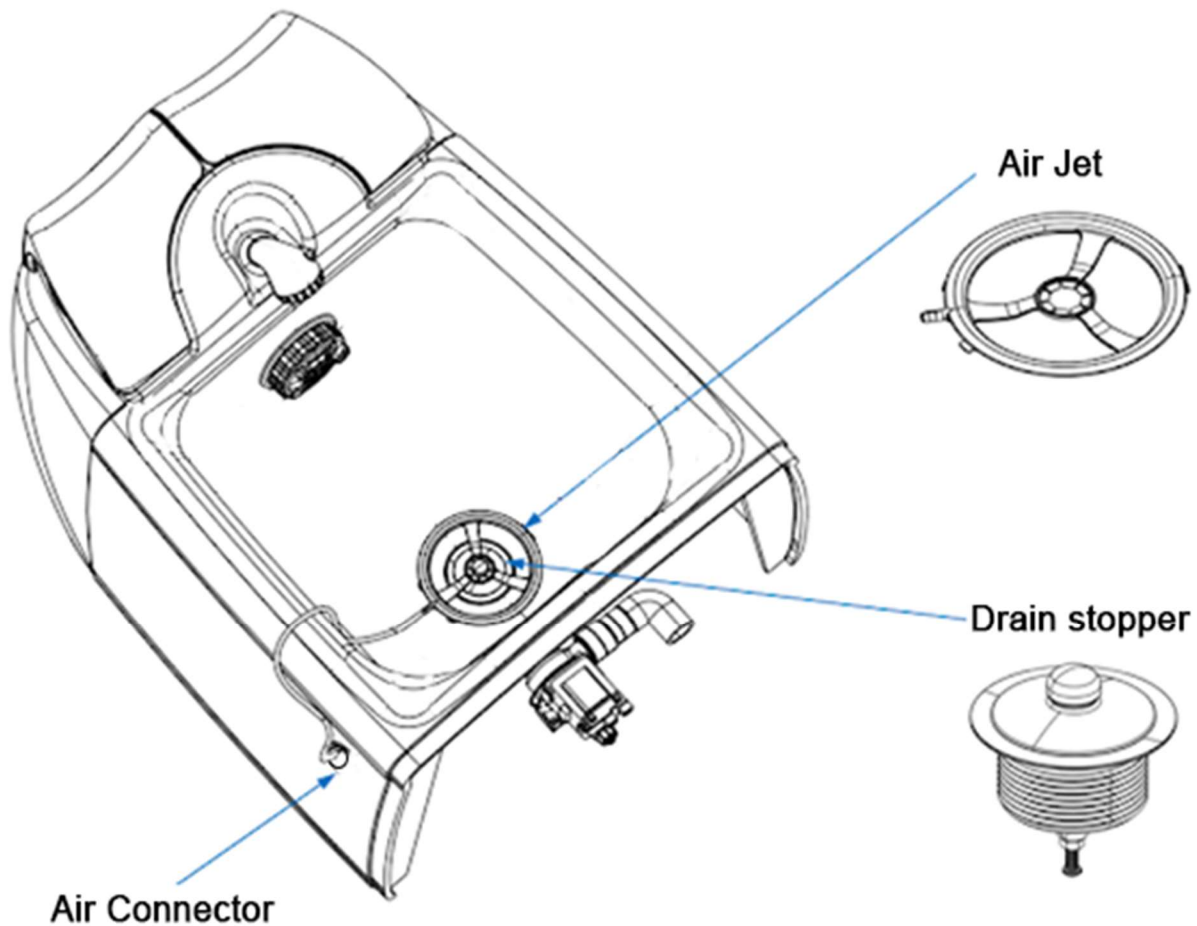
3. Drain Stopper



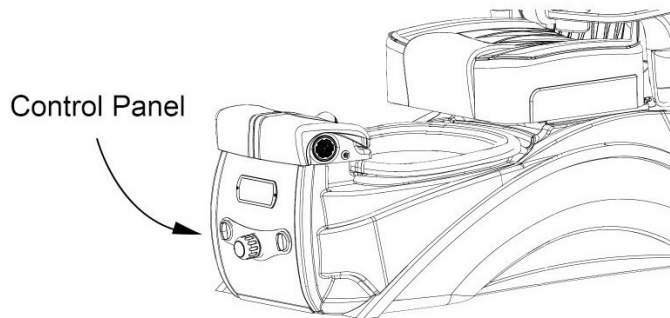
Use the blades on the drain stopper to poke through the liner for easy drainage access.

The system should be set as the picture below before each service section.

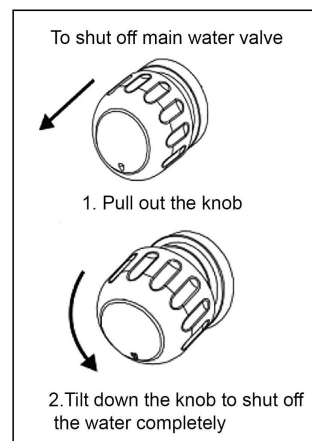
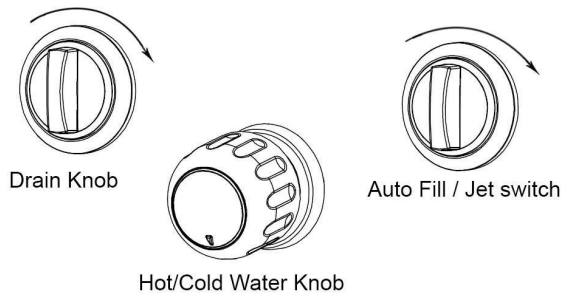

OPERATE Auto-Fill™/Jet Switch:



Locate the control panel at the front of the spa base. Follow the instructions below to operate the pedicure spa.



- Twist Auto-Fill /Jet switch clockwise then release to start auto-fill. Water will automatically shut off when it reaches the preset water level.
- To manually stop Auto-Fill water filling, twist the Auto-Fill /Jet switch clockwise again.
- Twist drain knob clockwise to start draining. Twist it back when the draining is done.
- Use "Hot/Cold water knob" to manually adjust the water temperature.
- To shut off the main water valve, follow the instructions on the right.

***** Water control knob is on by default. It should be shut down at the end of the day or when unattended to prevent water damage risks.**

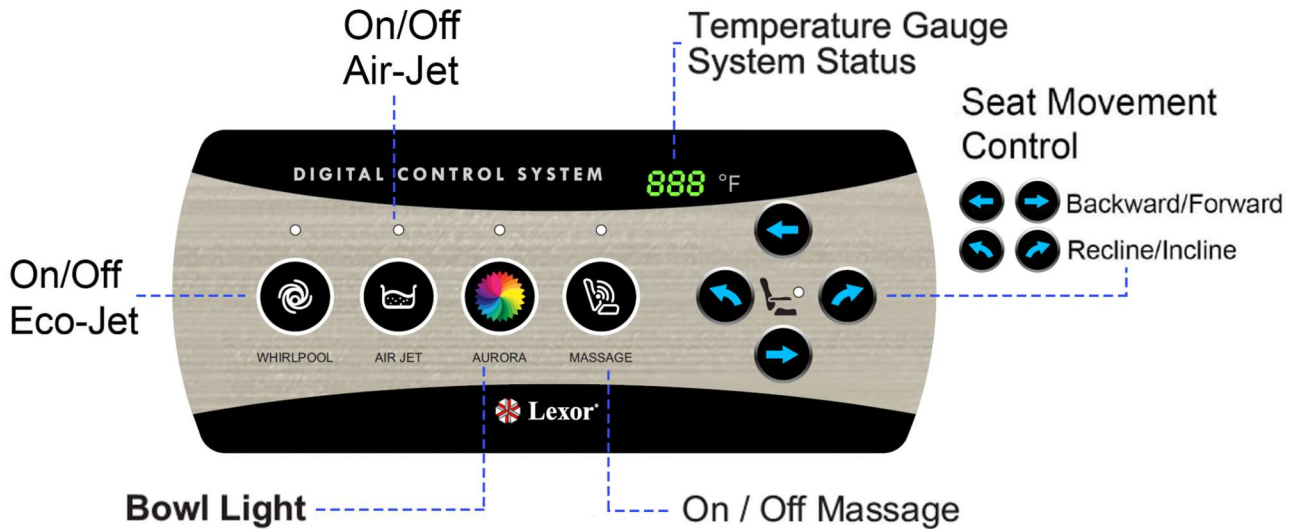


Function works when water level meets requirement, otherwise the screen will "dry", jet won't turn on.

- By default, Eco-Jet automatically turns on when the water level is up. To turn off the Eco-Jet manually, click the "Whirlpool button" on the digital control panel.

***** DO NOT DRAIN WATER WHEN ECO-JET IS RUNNING, OR THE DEVICE WILL BE BURNT OFF.**

OPERATE DIGITAL CONTROL PANEL(DCS):



-Light is automatically with the system Autofill while Eco-jet is activated, and turns off when system shuts off.

-**Turn on manually:** Click "Aurora" button.

-**Select Color:** Click to loop through 8 color options.
Stop at the selected color.

-**Turn off manually:** Press & Hold for 2s

❖ **The LED light indicates the current working status.**

❖ **The factory setting for Dual-Jet:**

- By default, Eco-jet automatically turns on with Auto-fill. Click the "WhirlPool" button to turn it on/off.
- Click the "Air-Jet" button to turn on/off the Air-jet.
- When draining starts, the air-jet, and Eco-jet automatically turn off. The settings will be memorized for the next section. When the system starts again, the dual-jet automatically turn on as the last section ended.

RESET WATER SENSOR AND WATER LEVEL

1. Reset the water sensor (Empty basin before activating this mode).



- A reset water sensor is required when the water level is out of range.

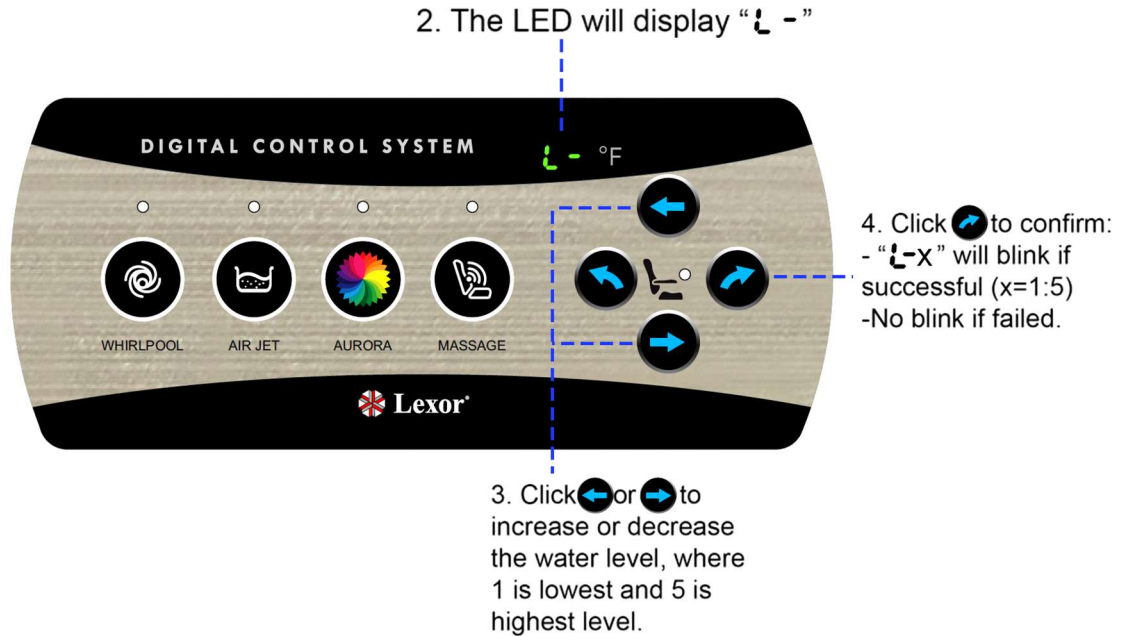
** Note:

- This will also reset the water level to default = 3.
- Click should be pressed slowly.
- Press and hold the "WHIRLPOOL" button again for 3 sec to resume system operation or the system will be automatically resumed if no action is taken in 20 sec.

2. Adjust the Water Level for Auto-Fill (Empty basin before activating this mode).

1. Press & Hold for 3 sec. The LED will display "CAL"
Click until "Adj" appears on the screen

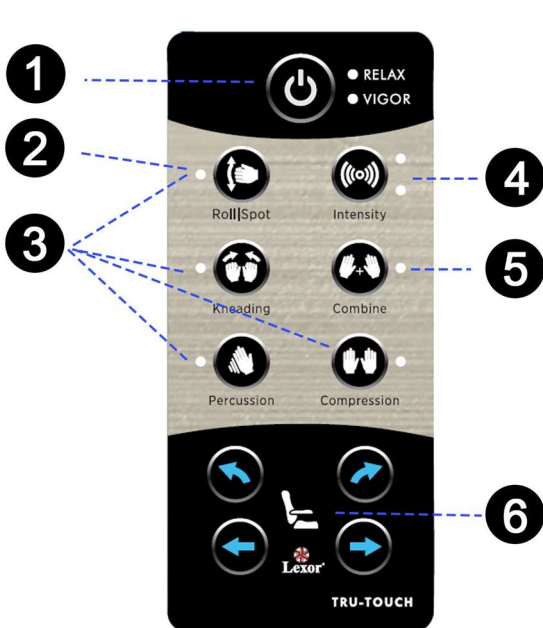




** Note:

- Click should be pressed slowly.
- Press and hold the "WHIRLPOOL" button again for 3 sec to resume system operation or the system will be automatically resumed if no action is taken in 20 sec.

MASSAGE SYSTEM & REMOTE CONTROLLER



1. Press to start Auto mode with RELEX (low intensity). Press again to switch to VIGOR (high intensity). Press again to turn off the massage. Auto and Manual mode will run for 20 mins.
2. Press Rolling/Spot to stop rolling up/down and stop at the desired spot.
3. Press any button (Rolling/Spot, Kneading, Tapping, Compression) to enter Manual mode with indicated action.
4. At Manual mode, press the Intensity button to select between Low and High intensity.
5. Press the Combine button to resume Tapping mode.
6. Press any chair button (Recline, Incline, Backward, Forward) to move the chair to desired positions.

Each State will have slight differences in cleaning policies, please check with your state's Bureau of Barbering and Cosmetology or Regulatory Authority for specific details.

Safety Requirements for Pedicure Spas

The Bureau of Barbering and Cosmetology requires that salons using whirlpool pedicure foot spas must follow these disinfecting procedures to ensure proper cleaning and maintenance of the equipment and prevent bacterial or parasitic spread disease.

Violation of this section may result in an administrative fine and/or disciplinary action. Each foot spa that is not in compliance with this section may result in a separate violation.

NOTE: Authority cited: Section 7312, Business and Profession Code. Reference: Section 7312 (e), Business and Profession Code.

Below is a suggestion for your pedicure spa chair's cleaning procedure:

After Each Customer

1. All water shall be drained, and all debris shall be removed from the spa basin.
2. The spa basin must be cleaned with soap or detergent and water
3. The spa basin must be disinfected with an EPA-registered disinfectant with demonstrated bactericidal, fungicidal, and virucidal activity, which must be used according to the manufacturer's instructions.
4. The spa basin must be wiped dry with a clean towel.

At the End of Each Day

1. The screen shall be removed, all debris trapped behind the screen shall be removed, and the screen and the inlet shall be washed with soap or detergent and water.
2. Before replacing the screen, the screen shall be immersed in an EPA-registered disinfectant with demonstrated bactericidal, fungicidal, and virucidal activity, which must be used according to the manufacturer's instructions.
3. The spa system shall be flushed with low sudsing soap and warm for at least 10 minutes, after which the spa shall be rinsed and drained.

At Least Once A Week

1. The spa basin shall be filled with warm water and 1 teaspoon of 5.25% bleach for each gallon of water, or a solution of Sodium Hypochlorite of approximately 50ppm used according to manufacturer's instructions.
2. The spa system shall be flushed with the bleach and water solution, or Sodium Hypochlorite solution, for 5-10 minutes and allowed to sit for 6-10 hours.
3. The spa system shall be drained and flushed with water before use upon a patron.

90-DAY PARTS EXCHANGE LIMITED WARRANTY ON INDIVIDUAL PARTS SOLD:

All purchased parts will be covered for 90-Day parts exchange only.

NON-WARRANTY PRODUCT:

This limited Warranty is not covered on Furniture, Technician Stools/Customer Chairs, and Accessories.

PART REPLACEMENT SHIPPING FEE:

Shipping fee for replacement parts are covered under this Limited Warranty. Customers must return the defective parts to Lexor. at customer's expense. The defective part must include the RETURN AUTHORIZATION NUMBER (RMA number) which is provided by Lexor's Customer Support Representative. The RMA number will help us locate the parts and complete the service in a timely manner. Lexor is not responsible for missing/lost returned defective parts which are being returned without the RMA number issued.

PARTIAL TERMS AND CONDITIONS OF LIMITED WARRANTY:
