






### WALL CLEARANCE & SPA to SPA RECOMMENDED CLEARANCE







**VERY IMPORTANT:** The wall clearance for dome-to-wall(0.5inches/1.25cm) and base-to-wall(10 inches/25.4cm) are mandatory to give enough space for the unobstructed chair recline and plumbing system connections. Failure to follow may result in serious damage to the SPA component and void the warranty.


### LOWER DOME ASSEMBLY






Step 1: Open the panel labeled "Lower-Dome" by removing 4 screws on both sides of the panel. Install lower-dome by inserting 2 mounting bolts from lower dome into spa base frame then secure 2 M8 x 100 bolts (attached near the mounting hole). Re-install the panel. Locate and connect both ends of LED light power cables.

### **UPPER DOME ASSEMBLY**







Step 2: Open the panel labeled "Upper Dome". Install upper-dome by inserting 2 mounting bolts from upper-dome into hole on lower-dome frame then secure 2 M8 x 25 bolts (attached near the mounting hole). Re-install the panel. Locate and connect both ends of LED light power cables.

### **INSTALLATION OF PEDICURE SPA SEAT**

### 1. FOLD & UNFOLD BACK-REST MASSAGE





Raise the backrest until a "click" is heard. Make sure the lever is locked before operating




To fold down the backrest: Lift up lever handle and push the backrest downward

### 2. BACK CUSHION ASSEMBLY







Install the back cushion by engaging the 2 bottom hooks of cushion onto the shaft of massage frame. Position the top of back cushion, then snap the fit joint of back cushion to the crossbar of massage frame, press the back cushion firmly on the massage frame to secure.



### 3. SEAT CUSHION ASSEMBLY





Install the seat cushion by engaging the 2-rear hooks of seat cushion onto the seat frame.

Position the seat cushion then snap the fit joint of seat cushion to the seat frame. Press the seat cushion firmly on the seat frame to secure.

Connect 5-pin male-female connectors labeled "2" from cushion seat to spa base.


#### NOTE:

5-pin cable connector must be routed under the seat frame.

DON'T plug 5-pin male connector labeled "2" into 8-pin female connector labeled "1".


#### 4. ARMRESTS ASSEMBLY

### **Armrests Assembly**




Position and line up both markers of the armrest and seat frame connectors. Engage both sides into guide joints. Horizontally rotate armrest counterclockwise (clockwise with Right Armrest) to lock it in place


Connect 8-pin male-female connectors labeled "1" between Right Armrest and Spa Base.






### INSTALLATION OF PLUMBING SYSTEM

**NOTE**: The drainage and water supply system installation require a licensed plumber. Detailed instructions can be found in the manual book. Instructions and local plumbing codes need to be carefully compiled to pass the city inspections.


#### 1. GRAVITY DRAIN


- 1) The gravity drainage installation should comply with SECTION 701.0, 2018 UPC.
- 2) Trap, vent, and connectors should comply with SECTION 1001.1 and 1001.2 UPC.
- 3) An alternative code needs to be complied with by the states not adopting UPC.
  - a) Drainage system: SECTION 701.2 and 702.2 IPC (or local plumbing code)
  - b) Trap, vent, and connectors: SECTION 1002.1 and 1002.2 IPC (or local plumbing code)
- 4) The installer/plumber is responsible for obtaining and complying with the local plumbing code for inspection. If any assistance is required from the vendor's side, please contact our customer service.

### 2. POWER DRAIN



- 1) The power drainage installation should comply with SECTION 807.1, 2018 UPC.
- 2) Trap, vent, and connectors should comply with SECTION 1001.1 and 1001.2 UPC.
- 3) An alternative code needs to be complied with by the states not adopting UPC.
  - a) Drainage system: SECTION 701.2 and 702.2 IPC (or local plumbing code)
  - b) Trap, vent, and connectors: SECTION 1002.1 and 1002.2 IPC (or local plumbing code)
- 4) The installer/plumber is responsible for obtaining and complying with the local plumbing code for inspection. If any assistance is required from the vendor's side, please contact our customer service.

### 4. HOT/COLD WATER SUPPLY SYSTEM

NOTE: The drainage and water supply system installation require a licensed plumber. Instructions and local plumbing codes need to be carefully compiled to pass the city inspections.






Figure 1. Drain water to remove debrits before installing new Spa chair.

**New constructions:** drain a good amount of water in a bucket to remove all debris from the new hot/cold water pipes before connecting to new SPA chairs (figure 1).

**Replacement Spas:** Make sure to use new hot/cold water hoses to replace old ones before installing a new Spa chair. The old debris, rubber, or plastic chips could clog the water inlet system.

\*\* Failure to do so will invalidate the warranty.

## **INSTALLATION OF VENTILATION SYSTEM (OPTIONAL)**

(The Spa comes with a preinstalled ventilation system because it is required by some state regulation. Please contact your state department for the requirements and regulations)



Step 1: Connect the two Air-vent hoses to the connector



Step 2: Use provided tie-wraps to secure the hoses on the connector.

Step 3: Tie-wrap the connector to the Spa Base.





### Installing Air Tube to Air Ring






Turn safety cap cover clockwise to open the safety device, next Insert the Air Tube into the safety device

You can choose either one of the 2 following options for setting up the air ring and drainage:


### 1. Not Using the Drain Stopper

The Air ring Stand should **face down**. Press down the Air ring to lock it into the Drain shoe.



### 2. Using the Drain Stopper

Air ring stand should **face up**Press down Air Ring to lock it into
the Drain stopper knob.
Note: The drain stopper will punch through
the plastic liner for drain water later






### OPERATE Auto-Fill™/Jet Switch:





Locate the control panel at the front of the spa base. Follow the instructions below to operate the pedicure spa





Push in button for manually shut off water

- Twist Auto-Fill/Jet switch clockwise then release to start auto-fill. Water will automatically shut off when it reaches the water sensor level.
- To manually stop Auto-Fill water filling, twist the Auto-Fill/Jet switch clockwise again.
- Twist drain knob clockwise to start draining. Twist it back when the draining is done.
- Use "Hot/Cold water knob" to manually adjust the water temperature.
- Push button on the Hot/Cold Water Knob to turn on/off main water valve.

\*\*\* Water control knob is on by default. It should be shut down at the end of the day or when unattended to prevent water damage risks.




Function works when water level meets requirement, otherwise the screen will "dry", jet won't turn on.

• By default, Eco-Jet will automatically turn on when the water level is full. To turn off the Eco-Jet manually, click the "Whirlpool button" on the digital control panel.

\*\*\* DO NOT DRAIN WATER WHEN ECO-JET IS RUNNING, OR THE DEVICE WILL BE BURNT OFF.

### **OPERATE DIGITAL CONTROL PANEL:**



NOTE: Press and Hold the Steam Heat Button for 3s. The system will activate the Air Jet without the Steamer

- The Blue/White LED light indicates the current working status.
- Eco-Jet action can cause small amounts of soap or body oil to foam excessively. For this reason, refrain from using these products during the whirlpool cycle.
- For safety reasons, the steam heat function is off by default. Press the button to turn it on.



### RESET WATER SENSOR AND WATER LEVEL

### 1. Reset the water sensor (Empty basin before activating this mode).



A reset water sensor is required when the water level is out of range.



- Click should be pressed slowly.
- Press and hold the SteamHeat Button for 3 sec to resume system operation or the system will be automatically resumed if no action is taken in 20 sec.

- 7. Press any chair button (Recline, Incline, Backward, Forward, Up, Down) to move the chair to desired positions.




Remove "Y" Air Connector by using Pliers to lose the metal ring then remove the connector.




Turn the Steamer counterclockwise ½ turn then lift to remove.



 Press down the latching lock on signal cable connector then pull out. 2. Using a wrench to remove the water hose.











Remove all the connectors on the front of AF-Control Box. Push up and pull AF-Control Box out of the holder then remove the 3 remaining power plugs.

### CLEANING PROCEDURE IS REQUIRED BY STATE BOARDS

Note: \*\*\* A cleaning log should be kept with each pedicure spa \*\*\*

Each State will have slight differences in cleaning policies, please check with your state's Bureau of Barbering and Cosmetology or Regulatory Authority for specific details.

### **Safety Requirements for Pedicure Spas**

The Bureau of Barbering and Cosmetology requires that salons using whirlpool pedicure foot spas must follow these disinfecting procedures to ensure proper cleaning and maintenance of the equipment and prevent bacterial or parasitic spread disease.

Violation of this section may result in an administrative fine and/or disciplinary action. Each foot spa that is not in compliance with this section may result in a separate violation.

NOTE: Authority cited: Section 7312, Business and Profession Code. Reference: Section 7312 (e), Business and Profession Code.

Below is a suggestion for your pedicure spa chair's cleaning procedure:

#### After Each Customer

- 1. All water shall be drained, and all debris shall be removed from the spa basin.
- 2. The spa basin must be cleaned with soap or detergent and water
- 3. The spa basin must be disinfected with an EPA-registered disinfectant with demonstrated bactericidal, fungicidal, and virucidal activity, which must be used according to the manufacturer's instructions.
- 4. The spa basin must be wiped dry with a clean towel.

### At the End of Each Day

- 1. The screen shall be removed, all debris trapped behind the screen shall be removed, and the screen and the inlet shall be washed with soap or detergent and water.
- 2. Before replacing the screen, the screen shall be immersed in an EPA-registered disinfected with demonstrated bactericidal, fungicidal, and virucidal activity, which must be used according to the manufacturer's instructions.
- 3. The spa system shall be flushed with low sudsing soap and warm for at least 10 minutes, after which the spa shall be rinsed and drained.

### At Least Once A Week

- 1. The spa basin shall be filled with warm water and 1 teaspoon of 5.25% bleach for each gallon of water, or a solution of Sodium Hypochlorite of approximately 50ppm used according to manufacturer's instructions.
- 2. The spa system shall be flushed with the bleach and water solution, or Sodium Hypochlorite solution, for 5-10 minutes and allowed to sit for 6-10 hours.
- 3. The spa system shall be drained and flushed with water before use upon a patron.
